### INSURANCE COVERAGE AND BAD FAITH

Kim has represented many insurers and their third-party administrators in coverage analysis, coverage opinions, the preparation of coverage denial and reservation of rights letters, serving as coverage counsel in cases where a reservation of rights was issued but declaratory judgment was not filed, and serving as counsel in cases where coverage was litigated in either a declaratory judgment, breach of insurance contract, or bad faith action, or where insurance companies sought contribution, indemnity, or equitable contribution or subrogation.

Kim's coverage practice is national in scope. He has been involved as lead coverage counsel in matters litigated in Florida, California, North Carolina, Kentucky, Texas, and South Carolina. Examples of some of the cases handled by Kim involving coverage and bad faith include the following:

- Successfully initiated coverage litigation and defended bad faith claims involving all of the following in related litigation: (1) a class action bodily injury and property damage claims arising out of negligent housing construction, (2) a bad faith claim against the carrier of a high profile charitable organization, and (3) officer and director claims by one high profile charitable organization against another and its officers and directors. This matter involved participating with multiple insureds, multiple lawsuits, and multiple states.

- Represented multiple insurance carriers and multiple claims involving bad faith and insurance coverage seeking to enforce judgments over \$100,000,000. As examples of these claims, they arose out of premises liability wrongful death, tractor-trailer accident, and allegations of widespread sexual abuse and molestation.
- Successfully initiated equitable subrogation claims on behalf of an excess carrier against other insurers within a tower of coverage. The claim arose out of a \$60M claim against an agricultural processor that allegedly permitted an allergen to contaminate raw materials that were incorporated into a final food product that had to be recalled.
- Successfully litigated coverage involving two related bodily injury/wrongful death claims against an apartment and property management company that included significant choice of law issue resulting in a victory before the 11<sup>th</sup> Circuit Court of Appeals.
- Successfully resolved a wrongful death case during litigation of related coverage issues of first impression arising out of the interaction of Georgia's statutory employer rules to a multiple-contractor construction accident and the General Contractor's employer exclusion in a CGL policy.
- Defended numerous insurance companies alleged to have failed to settle claims in bad faith resulting in judgments or settlements of millions of dollars.
- Successfully rescinded a policy of a mega-church in which the lead pastor was alleged to have breached fiduciary duties and engaged in wrongful sexual conduct with minor and adult women of the church.
- Regularly called upon to guide insurance companies through the complexities of "gotcha" policy limit demands designed to be too complex to comply with to try to bust the insurance carriers' policy limits in a bad faith claim.
- Obtained summary judgment and recovered attorney's fees for a liability insurer sued as garnishee following a judgment against its insured arising out of a professional liability action. The Federal Court sides with the insurer and awarded

defense costs under Georgia's garnishment statutes.

- Won summary judgment or judgment on the pleadings in multiple coverage matters relying upon a client's assault and battery exclusion in its commercial general liability policies.

## **PROFESSIONAL LIABILITY EXPERIENCE**

### **Legal Malpractice, Professional Liability and Bar Defense**

Kim has represented many attorneys in both civil claims brought by clients and non-clients in Georgia, Texas, California, and Ohio, and in licensing issues brought before the State Bar of Georgia.

As a subset of this practice, Kim regularly is asked to defend lawyers and their clients against claims for sanctions or opposing counsel's attorney fees and litigation expenses arising out of Federal Rule 11, 28 U.S.C. 1927, and Georgia's abusive litigation statutes, including OCGA § 9-15-14, OCGA § 9-11-68, and OCGA § 51-7-80 *et seq.*

Among the many cases that Kim has handled include the following examples:

- Obtained a defense verdict following a two-week jury trial of a legal malpractice claim involving an allegedly missed statute of limitation on a construction lawsuit. The jury found that the law firm had not breached the standard of care.
- Obtained summary judgment for a commercial closing attorney who had notarized a forged guarantee. The loan later resulted in a \$1.8 million default. Summary judgment was granted based on an argument that the Plaintiff's claim relied solely on a violation of criminal notary law that did not support a civil remedy.
- Authored a successful amicus curie brief to the Supreme Court of Georgia on behalf of an attorney client that was facing a legal malpractice action had the Supreme Court not reversed the Court of Appeals ruling and issue a decision of first impression in the client's favor.
- Won summary judgment in a legal malpractice case on an issue of first impression involving the application of res judicata against a corporation with a complex corporate structure.

- Obtained summary judgment, which was upheld on appeal, for business litigation attorneys accused of failing to sufficiently document their client's settlement agreement arising out of a real estate development.
- Obtained a reversal of a Supreme Court issued suspension, then tried the bar complaint on the remand before a special master. The lawyer was eventually issued a private reprimand rather than the two-year suspension issued prior to Kim's representation.
- Obtained a judgment on the pleadings against a workers' compensation attorney accused of negligently advising a client to engage in conduct that resulted in a criminal conviction for fraud.
- Successfully defended and argued before Georgia's Supreme Court the constitutionality of Georgia's affidavit of merit statute.
- Successfully defended a family law attorney against a large six figure sanctions award by twice having the trial court's judgment overturned by the Georgia Court of Appeals.

## **PREMISES LIABILITY**

Kim represents landowners, security guards, and property management companies in premises liability matters of all types, including claims arising out of falls, third-party criminal acts, and mold exposure.

Examples of some of these defenses include the following:

- Obtained a dismissal, which was upheld on appeal, in favor of a security company alleged to have illegally used radar to enforce traffic regulations in a private, gated community. The claims included false imprisonment, fraud, and theft by taking.
- Has obtained summary judgment for apartment owners and their property management companies in claims involving mold exposure on the basis that the plaintiff has failed to sufficiently link the alleged personal injuries to the alleged mold exposure on multiple occasions.

- Obtained judgment on the pleadings in favor of a security guard on civil rights claims brought by the parents of a hospital patient who were escorted off the property following a dispute over the medical treatment of the child.

## **OTHER EXPERIENCE**

Throughout Kim's career, he has been involved in all kinds of cases under the umbrella of his insurance defense practice. Kim's early career included trying dozens of auto accident and premises liability cases, and representing auto-dealers in consumer fraud cases, grocery stores and pharmacies in all types of liability cases, restaurants in food poisoning cases, and transportation companies in semi-truck accidents.

Kim's current practice includes, in addition to the above discussed types of claims, defending government entities in civil rights claims, including 1983 claims, defending insurance agents and brokers in professional liability claims.

As a result of this varied background, Kim's experience includes such diverse cases as the following:

- Drafted the briefs that obtained summary judgment for a portable plastic gasoline can manufacturer in a wrongful death case arising out of a home fire that began in an indoor wood burning stove/fireplace.
- Obtained summary judgment for fast food franchisees on claims for food poisoning based on an analysis of the scientific evidence.
- Defending a spa from allegations of inappropriate sexual touching by massage therapists.
